



Draft Sefton Economic Strategy Consultation



An Economic Strategy is a plan that looks at the business and employment needs of an area. It sets out what the Council will do to meet these needs.

Sefton Council has a Sefton Economic Strategy but work on this changed because of the COVID-19 pandemic.



Now that we are recovering from the pandemic, we need to look again at the Economic Plan for Sefton again to make sure:



- The information is correct and important for Sefton.
- Whether the four themes are the correct themes.

KEY FACTS

We collect lots of information to help develop the plan called **Key Facts**, like:

- How many people are in work?
- How many people do not work?
- How many people work as managers?
- How many people have an NVQ4 qualification or above?
- How much people get paid a week?
- How many people are on benefits?





There are areas of Sefton where there are more people who do not work. If they work, the money they get is less than in other areas of the borough. One of the areas is Bootle. Another area is part of Southport.



Sefton is part of the Liverpool City Region. The Liverpool City Region is an area that covers Sefton and

- Knowsley
- Halton
- St Helens
- Liverpool
- Wirral



The Liverpool City Region works together to create jobs, have easier transport links, and organise events.



In Sefton there are not as many businesses as other parts of the Liverpool City Region and of England. We need to create and develop more businesses.



Lots of people in Sefton work for

- Sefton Council
- Health
- Schools
- The Fire Service
- The Police





Lots of people who live in Sefton travel outside of Sefton to go to work.



During the pandemic, lots of people worked at home more.



The way people work has changed, and this will have to be looked at.



A lot of older people live in Sefton. This means that there is likely to be less working age people (aged 16 – 64) in the future.

The need for adult social care will be higher.



In Sefton, there will be a need to attract people to work in Sefton and to keep them as members of staff.



More people in Sefton are learning new work-related skills.



There are more people aged 16 – 64 years, who have got an NVQ4 qualification and above.



There are some areas of Sefton where people are not as skilled as other areas of the borough.

The number of people getting unemployment benefits now is lower than during the Covid-19 pandemic.



Good transport routes in Sefton help people get to work.



There is a demand for housing that people can afford in Sefton.

There is a lack of land for building houses though.



From the information above, we think that the four main themes for the Sefton Economic Strategy are:

- **Employment** and opportunities for work
- **Business Growth** and Investment
- **Social inclusion** and access for all - where individuals and groups can take part in the area where they live.
- **Regenerated places** - to improve the places where people live.







What personal information we collect.

In this consultation we collect

- IP address
- Name, Organisation name, email address and postcode of business
- Business support information
- Age
- Sexuality
- Gender
- Disability
- Religion

Why we collect and use this information



IP addresses that identify computers

- The IP addresses are collected to make sure only one response per resident is received.
- Once this is checked the IP address information is deleted.
- Business support information (if applicable) so we know what support businesses need
- Your name, organisation name, email address and postcode of the organisation (if applicable) will be used if you have said that you would like to be kept up to date about the Economic Strategy

developments or be part of developing the Strategy



Equalities Questions

These are collected to show what groups of people are responding to the questionnaire.

This also lets us know if we need to use different ways to contact groups of people who are not responding.




How long we keep your information

The IP address will be deleted immediately after the checks are done.



Your contact details and the type of support businesses need will be kept for no more than two years.

The equalities information will be kept until the information has been looked at and a report written.



How we use the information and who we share the information with

The information collected in this questionnaire will only be used as numbers in the report.

No information is included in the report that tells us who you are.



Storing the information

All information is kept safe. Sefton Council follows the laws around data protection.



The laws

We need to make sure we

- Only ask the questions we need to in the questionnaire.



- Ask equalities questions. The law says we must ask and act on this information.

It helps us to know what groups of people are responding to the questionnaire.

It also helps us to know we are not missing groups of people.



Confidential

Your answers will not tell us who you are.

The answers will be collected to help us know what people think.



Who will we share this information with?

Your personal information will not be shared with any other organisation.



Asking to see your personal information

You can ask to see what personal information we keep about you. Be aware there are some rules about why some information cannot be shared.
